Cheshire & Merseyside (C&M) AMR Activities

- Virtual Reality (VR) learning piloting phase the filming is now complete and post production work will be completed towards the end of February 2020. We will be pilot testing the VR headsets with the learning scenarios during March 2020 and aim to roll out the VR training resources and downloadable videos April to May 2020. The Learning scenarios cover: recurrent and uncomplicated UTI; cough; sore throat; and sepsis.
- The single antibiotic formulary work is now nearing conclusion. This will be out shortly for local adoption across Cheshire & Merseyside. The planned next steps for this working group would be to arrange a meeting with the AMR lead pharmacists and formulate our priorities for further review work.
- Pharmacy antibiotic checklist C&M AMR Board members are working with NHS England and PHE colleagues to consider and develop an approach in Cheshire & Merseyside to be able to implement a pharmacy antibiotics checklist within community pharmacies. The pharmacy antibiotic checklist is developed by PHE Primary Care and Interventions Unit, HCAI & AMR Division.
- Target Toolkit: The medicines management team members of the AMR Board are providing information and support around the use of the Target Toolkit and delivering some direct training sessions as requested. New and Recent Publications

- There is a drive to reduce unnecessary antibiotic prescribing in patients with Chronic Obstructive Pulmonary Disease (COPD) exacerbations, in whom there is a high level of antibiotic use.
- A randomised control trail published recently in New England Journal of Medicine Here involving 649 adults with a flare-up of COPD attending 86 general practices in the UK found that fewer patients in the C Reactive Protein (CRP) testing guided group reported antibiotic use than in the usual-care group (57.0% vs. 77.4%; adjusted odds ratio, 0.31; 95% confidence interval [CI], 0.20 to 0.47).
- CRP-guided prescribing of antibiotics for exacerbations of COPD in primary care clinics resulted in a lower percentage of patients who reported antibiotic use, with no evidence of harm.
- This study provides strong evidence to suggest that rapid point-of-care CRP testing may help with antibiotic stewardship, without compromising patient safety. The findings seem likely to influence future guidance and practice.
