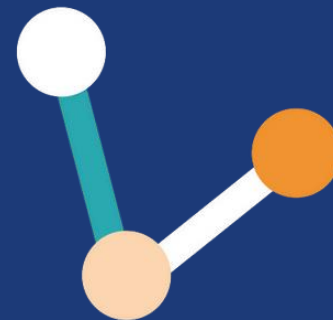

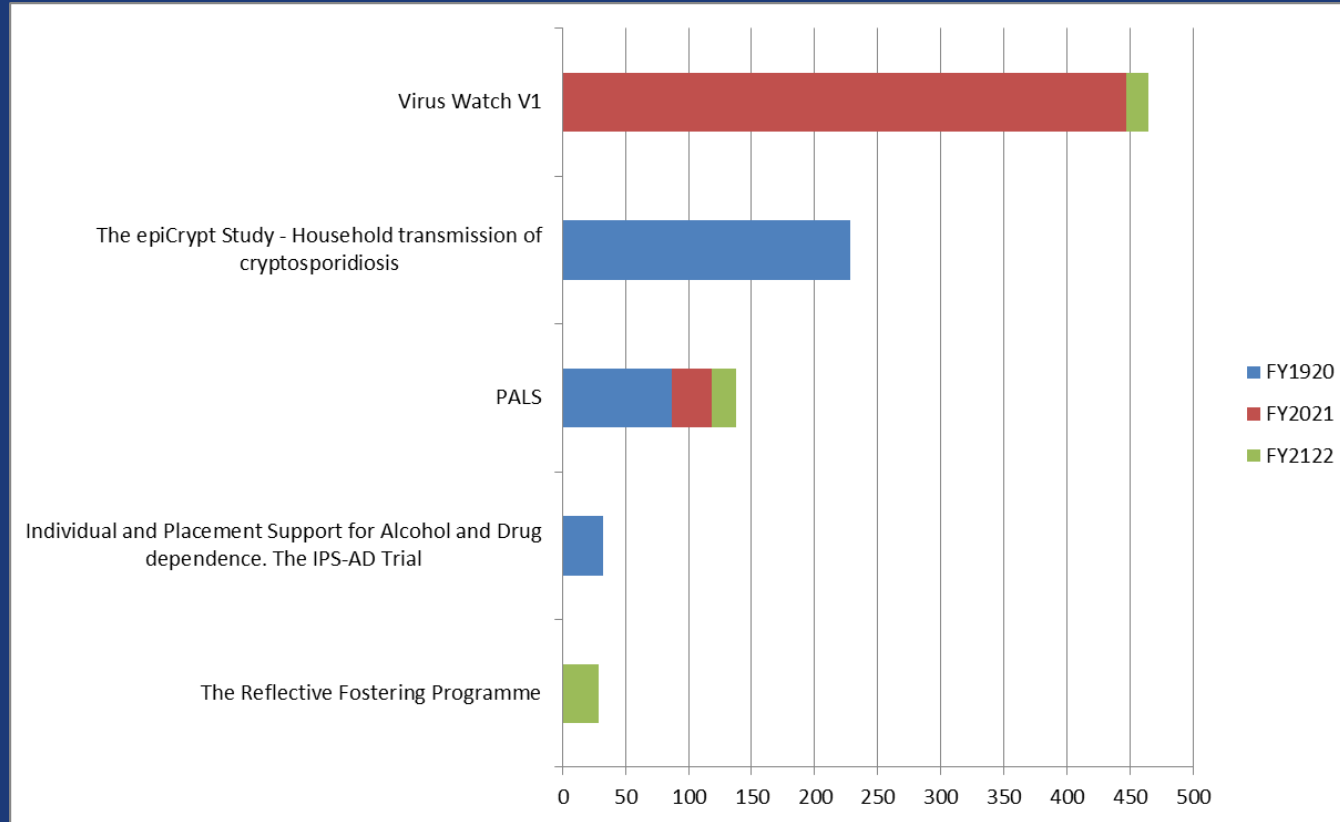
What is the added value?

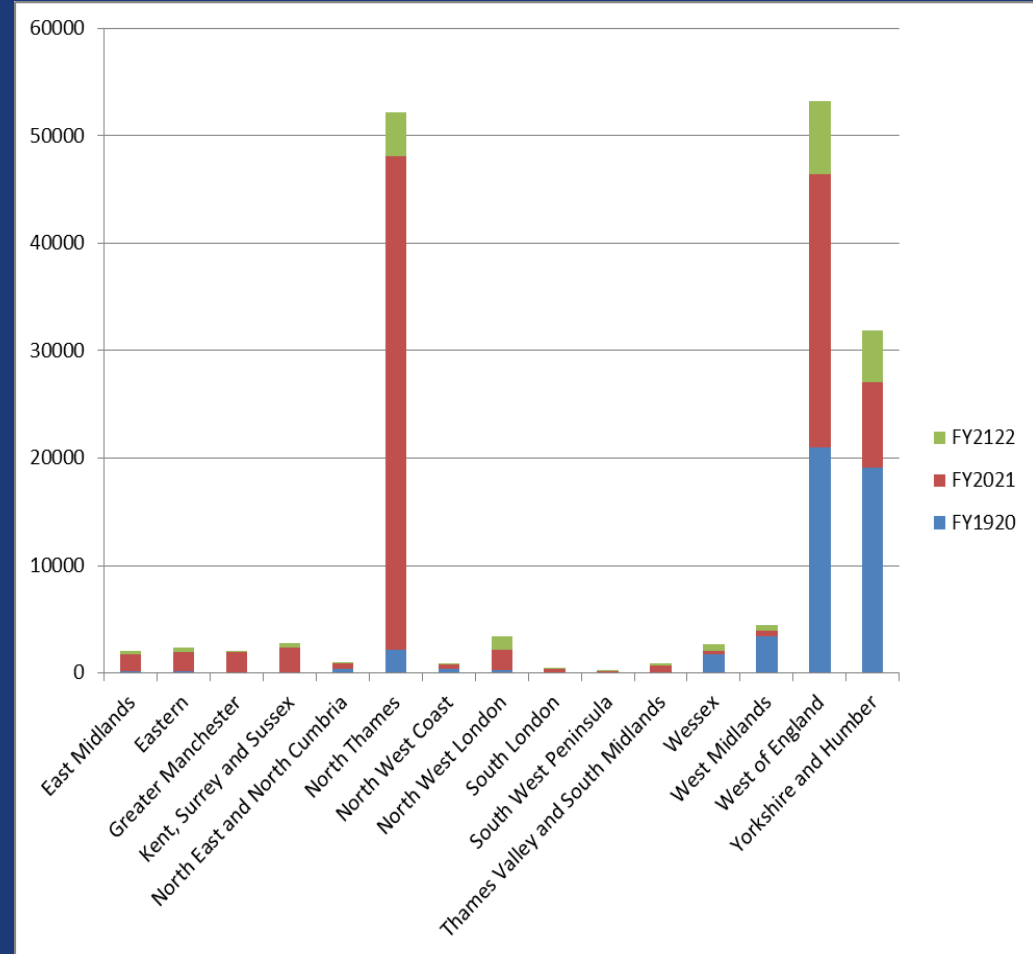

Examples of local collaboration :

- Cheshire West and Chester BC - Helen Bromley – close collaboration with University of Chester
 - Age friendly borough & Age well centre - led to baseline survey gathering info from population - transport, housing, access to leisure etc - 5 year programme – largest survey of kind
 - Chester LA independent evaluation of covid testing/contact tracing/outbreak response – real time feedback that influences future programme delivery
 - PENDING BIDS in design
 - Homelessness
 - Gaps in Adult social care
- 20 month response to urgent public health research - LAs LSTM CRN
 - RAPTOR (UoL, Liverpool LA, LSTM, LCRN)
 - AGILE
 - PRINCIPLE
 - PENDING PANORAMIC
- Professor Ben Barr- £600,000 awarded to study investigating if Preston holds the keys to ‘Building Back Better’ post-Covid. The National Institute for Health Research (NIHR) has invested £600,000 to investigate “The health and health inequalities impact of a place- based Community Wealth Initiative (CWI)” which has become known nationally as [‘the Preston Model’](#).
