### PROFESSOR OF HEALTH POLICY AND MANAGEMENT

David is Emeritus Professor of Health Policy and Management, Population Health Sciences Institute, Newcastle University. A graduate in political science from the University of Edinburgh, his academic career spans over 40 years researching health systems.

From 1999 to 2017, David was Professor of Health Policy and Management at Durham University and Director of the Centre for Public Policy and Health, School of Medicine, Pharmacy and Health. The Centre was designated a WHO Collaborating Centre in Complex Health Systems Research, Knowledge and Action. David is Emeritus Professor at Durham University, and a Senior Fellow, Global Policy Institute, School of Government and International Affairs.

He is a Visiting Professor, University of Chester, and a King's Fund Population Health Associate. He is a member of WHO's Global Network on Long-Term Care. He is a Trustee on the Ways to Wellness Foundation Board.

Former positions include: non-executive director, National Institute of Health and Care Excellence (NICE); Appointed Governor, South Tees Hospitals NHS Foundation Trust; and special advisor to the UK Parliamentary Health Committee. David is an Honorary Member of the UK Faculty of Public Health, and Fellow of the Royal College of Physicians (Edinburgh).



## PROFESSOR OF PUBLIC HEALTH

Paul Lincoln has worked In public health at local, national and international levels in the public and third sector. For 40 years. He is currently the Chair of one of the National Institute of Clinical and Health Excellence standing Public Health Advisory Committees and Chairs the Diabetes guidelines committee. He also chairs the alcohol advisory group for PHE and its successor organisation. He is involved with research investigations on trade and health and is a strategic adviser to many national charities.

Previously he was Chief Executive of the UK Health Forum and a Director of the Health Education Authority and a Chair and member of numerous Government and scientific expert public health advisory groups

He was awarded an OBE in the 2008 New Year honours list for services to healthcare and is an honorary fellow/member of the Royal College of Physicians, the Association of Directors of Public Health, Faculty of Public Health and a Professorial Fellow to the Royal Society of Public Health. He is also a visiting Professor at Chester University
